ADOPTING THE 1st AMENDMENT to the “FCH 2 JU 2021 ANNUAL WORK PLAN
AND BUDGET “**

**THE GOVERNING BOARD OF THE FUEL CELLS AND HYDROGEN 2 JOINT
UNDERTAKING (FCH 2 JU),**

HAVING REGARD TO the Statutes annexed to Council Regulation (EC) No 559/2014 of 6 May 2014 establishing the Fuel Cells and Hydrogen 2 Joint Undertaking¹ (FCH 2 JU), and in particular Article 7(3)(c) and (g);

HAVING REGARD TO the Financial Rules of the FCH 2 JU adopted by the Governing Board on 18 December 2019², and in particular Articles 6(5), 17(1) and 33(4);

HAVING REGARD TO the FCH 2 JU Governing Board Rules of Procedure³, and in particular Article 11 thereof;

WHEREAS:

- 1) The Annual Work Plan and Budget for 2020 adopted by Governing Board Decision of 16.12.2020⁴ needs to be amended.
- 2) The Budget should be amended to include the unused commitment and payment appropriations from administrative and operational expenditure from 2020 in accordance with Articles 6(5) and 17(1) of the Financial Rules of the FCH 2 JU and decrease the Union contribution with regards to FP7 operational payments.
