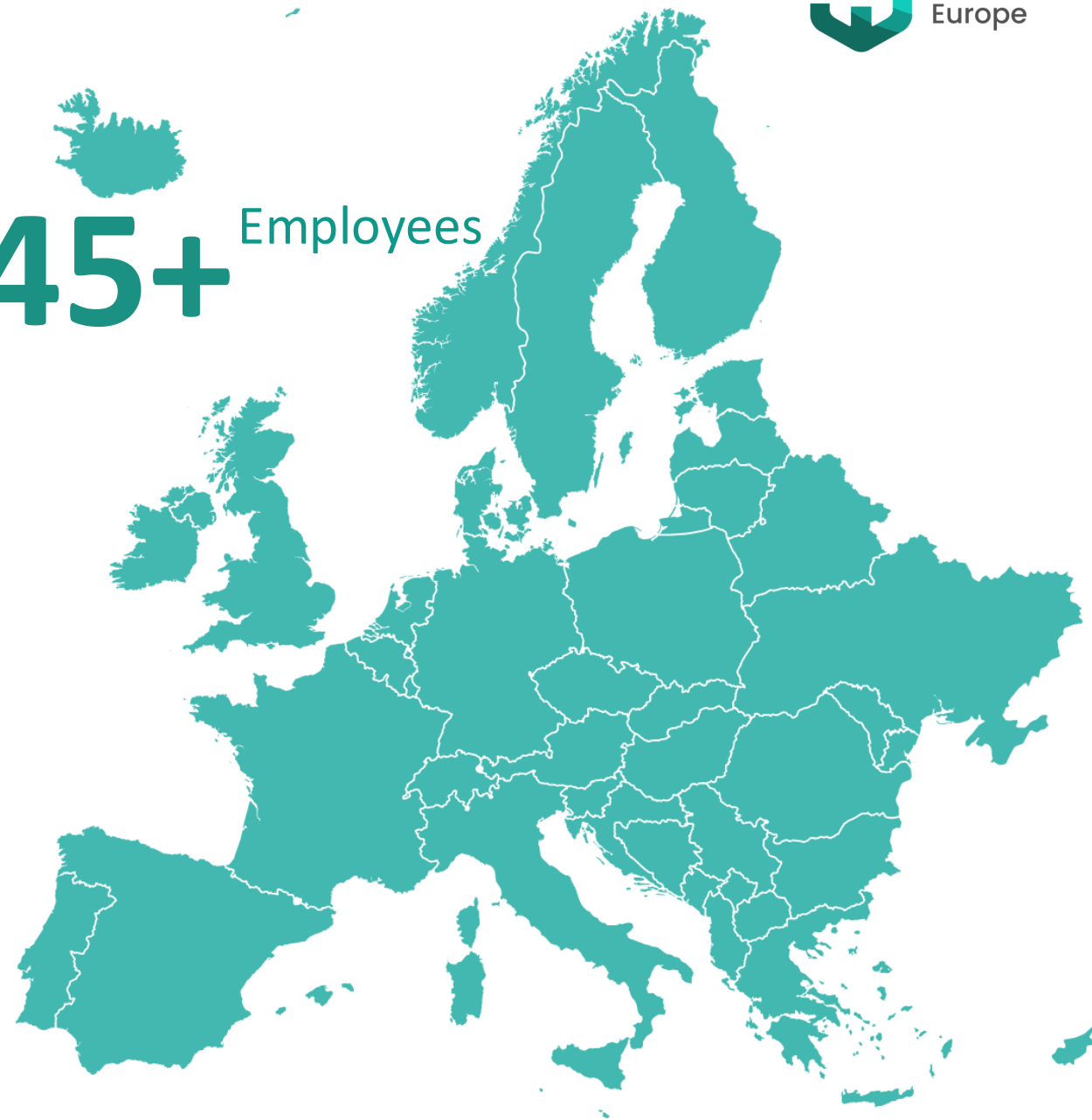

We represent the European Hydrogen Scientific Community with over **160 members** in **30 countries**.



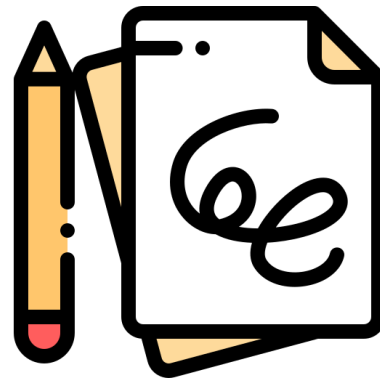

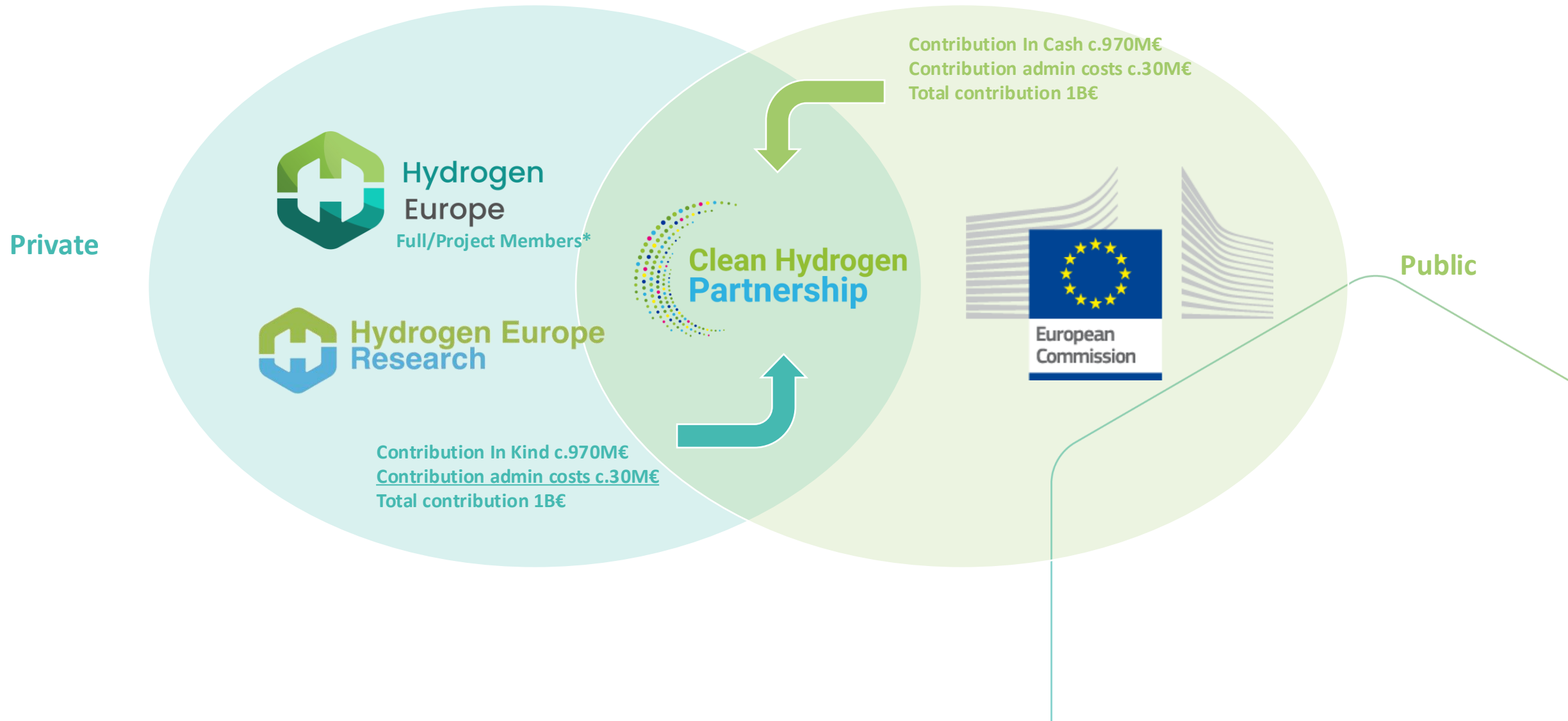

- 30M€ from 2021 to 2031

Approach

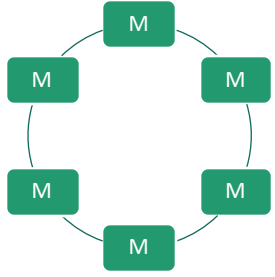
- 3,5% Programme Contribution from Hydrogen Europe / Hydrogen Europe Research members in successful consortia

Key principles

- Only members of Hydrogen Europe / Hydrogen Europe Research can contribute to the Programme Contribution
- SBA encourages membership of HE / HER to contribute to the success of the Partnership and the hydrogen ecosystem as a whole
- Non-members can join Hydrogen Europe as full members or program members

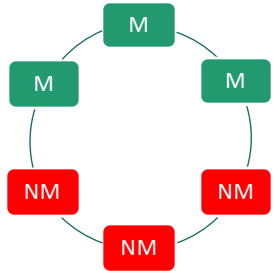

JU's administrative costs in consortium



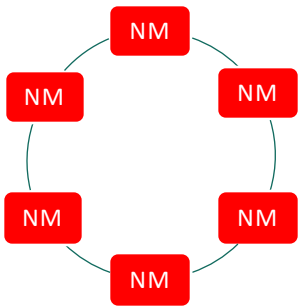
Example 1:

- Consortium with 6 members of HE/HER
- They all contribute to a 3,5% Programme Contribution



Example 2:

- Consortium with 3 members of HE/HER and 3 non members
- 3 options + combination (next slide)



Example 3

- Consortium composed of only non-members.
- This can jeopardise the whole system & put the associations at risk

Extract from HER Statutes, Article 48.4.c & d:

“The [HER] Members and the members of Hydrogen Europe AISBL part of a consortium that has been awarded a grant from the European PPP on FCH shall introduce in the consortium agreement a clause organising the collect of the project contribution. Each such clause shall provide for payment of the project contribution from and under the first payment instalment received by the member beneficiaries under the relevant European PPP on FCH project.”

“The [HER] Members and the members of Hydrogen Europe AISBL part of a consortium that has been awarded a grant from the European PPP on FCH are jointly liable for the payment of the project contribution and shall organise the repartition of the payment among them.”

Extract from HE Bylaws, Article 47.4.e:

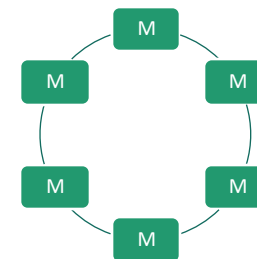
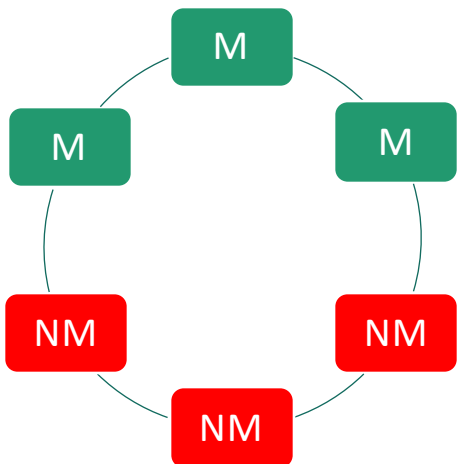
“If participants in the consortium are not yet Members of the Association and Hydrogen Europe Research AISBL, the participants that are Members shall invite them to consider becoming a Member (including a Programme Member). This will have the benefits to allow them to provide their share of the programme contribution.”

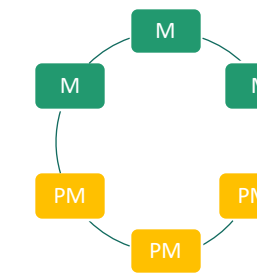

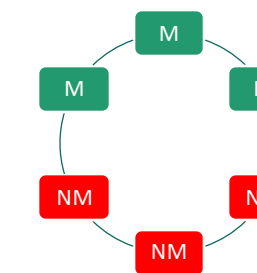
Example 2: Consortium with 3 members of HE/HER and 3 non members
→ 3 options + combination



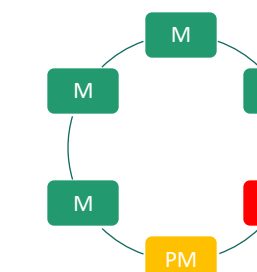
The three non-members become **full members of HE/HER**
+
They all contribute to a 3,5% Programme Contribution



The three non-members become **programme members of HE**
+
They all contribute to a 3,5% Programme Contribution



The three non-members remain **non-members**.
→ They do not pay the contribution, directly or indirectly.
→ The **three members only** cover the Programme Contribution



Combination of the 3 options

Identify research priorities and draft topics in the context of the Clean Hydrogen Partnership



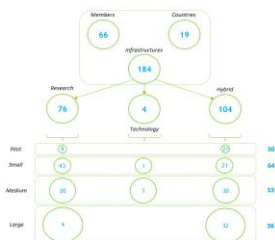
Participate in the European debate on hydrogen and write policy recommendations via the Policy Working Group

Access the Research & Technology Infrastructure Mapping to understand what activities other organisations are performing and what kind of infrastructures they have



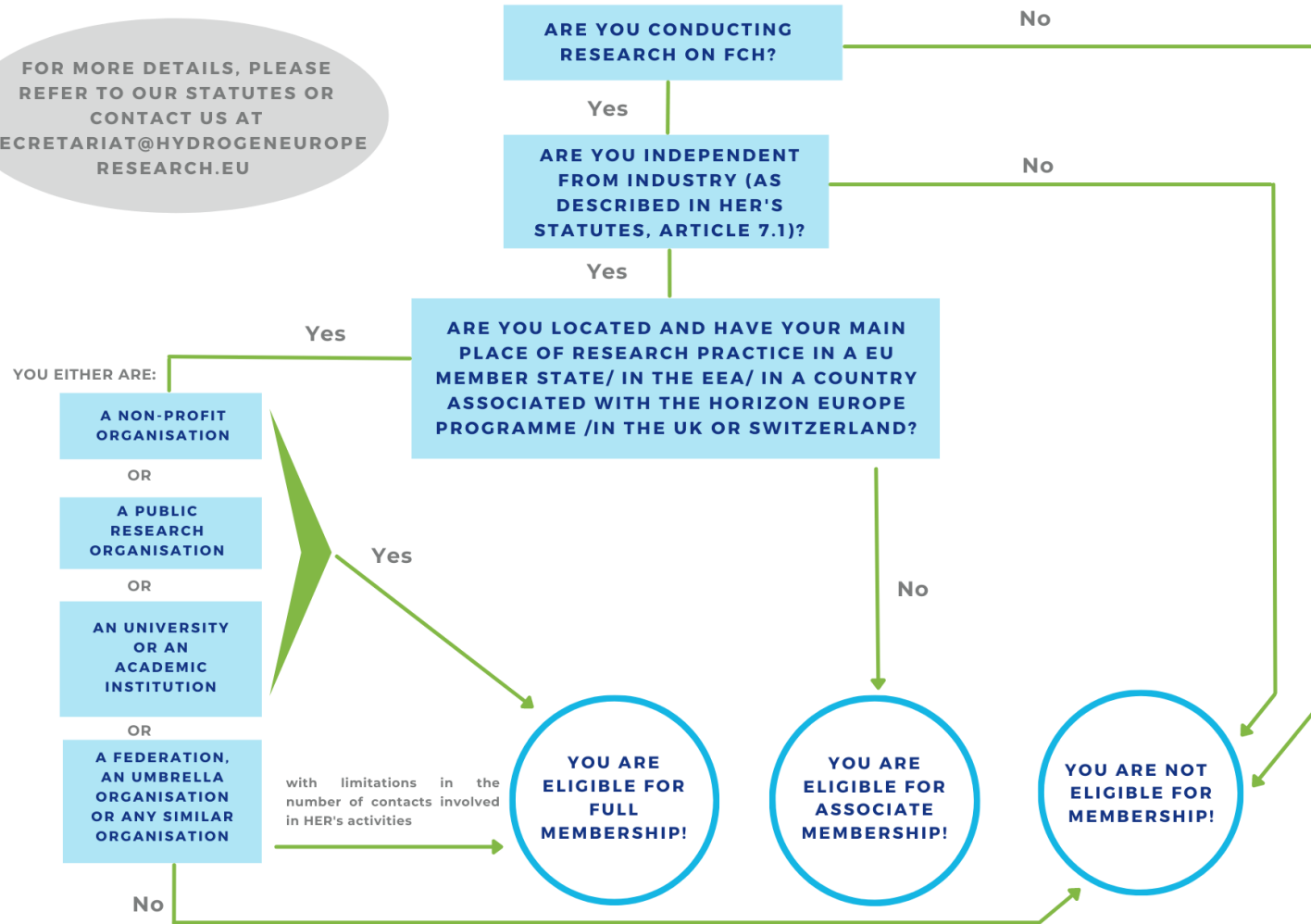
Access networking opportunities via the General Assemblies and participate in many events and initiatives we organise every year (for example, the Young Scientist Award)
