DECISION OF THE GOVERNING BOARD OF THE FUEL CELLS AND **HYDROGEN 2 JOINT UNDERTAKING OF 20 APRIL 2020** ADOPTING THE 1st AMENDMENT to the "FCH 2 JU 2020 ANNUAL WORK PLAN AND BUDGET "

THE GOVERNING BOARD OF THE FUEL CELLS AND HYDROGEN 2 JOINT UNDERTAKING (FCH 2 JU),

HAVING REGARD TO the Statutes annexed to Council Regulation (EC) No 559/2014 of 6 May 2014 establishing the Fuel Cells and Hydrogen 2 Joint Undertaking¹ (FCH 2 JU), and in particular Article 7(3)(c) and (g);

HAVING REGARD TO the Financial Rules of the FCH 2 JU adopted by the Governing Board on 18 December 2019², and in particular Articles 6(5), 17(1) and 33(4);

HAVING REGARD TO the FCH 2 JU Governing Board Rules of Procedure³, and in particular Article 11 thereof;

WHEREAS:

- 1) The Annual Work Plan and Budget for 2020 adopted by Governing Board Decision of $13.12.2019^4$ needs to be amended.
- 2) The Budget should be amended to include the unused commitment and payment appropriations from administrative and operational expenditure from 2019 and 2018 in accordance with Articles 6(5) and 17(1) of the Financial Rules of the FCH 2 JU as well as additional contribution from the European Commission. reflecting the revised forecast for FP 7 payments
