#### **Project goals**



- Develop modular material for training of regulators and safety officials
  - Focus on hydrogen safety approaches and standards
  - Main target : safety auditors and permitting officials
- Develop a vision and road-map for permanent training activities
- Impact will be to shorten approval process for hydrogen installations

"The HyFacts project aims to develop and disseminate fully up-to-date contemporary material in the form of customized training packages for regulators and public safety experts providing accurate information on the safe and environmentally friendly use of hydrogen as an energy carrier for stationary and transport applications under real conditions. The training material will focus on the fundamental aspects of hydrogen safety and on the safety approaches and criteria developed in standards and according to which hydrogen systems are engineered for the safe use of hydrogen under all circumstances."
